REGISTRATION: All Valley Brook classes have a limited enrollment. All applications require a non-refundable registration fee (\$50 for returning families, \$75 for new families) as well as a deposit of 10% of the annual tuition before discounts. Deposits are fully refundable until April 30, 2012.

TUITION PAYMENT OPTIONS (Please Select One): For your convenience, Valley Brook offers two payment options:

Payment in Full: 5% discount for tuition paid in full by Friday, September 7, 2012.

Monthly Billing (9 Installments): 1/9 of tuition balance payable monthly on the first of the months September-May.

Valley Brook offers a sibling discount of 10% applied to all children after the first child enrolled during the same school year and against the lesser of the tuition fees. No adjustments will be made due to absences or illness. Valley Brook requires a 30-day written notice prior to the effective date of any withdrawal. Any refunds due will be prorated based on the effective date. Parent hereby gives permission to Valley Brook to photograph or videograph their son/daughter and to use these pictures for brochures, websites, advertising and/or display purposes. Parent also gives permission to distribute to other school families the above information on a class list. All returned checks and late payments are subject to a service fee.
